- 01 The Post Graduate Diploma in Rural Management is a one-year course designed to sensitise managers in the public and private sectors to the realities of rural India. It is designed for those who are already employed so that they can take the course while working. It is affiliated to the University of Mumbai. The Diploma covers ten subject viz. Rural Governance & Fiscal Decentralisation, Economics for Rural Management, Organizational Behaviour & Human Resource Management, Management of Rural Services and Institutions, Farm Services Management, Agri-Business Management, Co – Operative & Collective Action, Managerial Accounting & Finance, Research Method and Marketing Management.
- 02 Based on the experience of the last two years, the diploma programme has been streamlined and rationalized, greatly reducing the travel and lodging costs of the participants in order to attract more participants from across the country.
- 03 The earlier & revised fee structure is as follows:-

(A) Earlier Fee Structure :

- a. Residential : Rs. 65000/-
b. Non Residential : Rs. 50000/-

(B) Detailed revised fee structure is as follows :

For residential course fees :

- a. With printed notes : Rs. 24500/-
b. Notes in CD/ DVD format : Rs. 22700/-

(C) For non residential course fees :
