Quotation received after the said date will not be considered. Undersigned reserves the right to reject all quotation without assigning any reasons, therefore.

**02.** Following documents should be submitted with the quotation in the sealed envelope.

**03.** Vehicles for inspection and its document is available from 18/03/2024 to 19/03/2024 between 11:00 AM To 12:30 PM in YASHADA at Transport Department. No counter conditions or relaxations of conditions mentioned in quotation will be accepted.

**04.** Bid will be open on 26/03/2024 11:00 am.

**05.** After bids are opened, auction will be conducted amongst the bidders with the highest offer as starting bid. Only top three bidder, or those whose bid is up to 25% below the highest bidder, which ever is more will be eligible to participate in the limited auction after opening the bid.

**06.** Director General, YASHADA reserves the right either to accept / reject any offer at his discretion. After offers are opened, sale may be postponed or cancelled or Director General, YASHADA at his discretion can hold a limited auction amongst Bidders who have offered bids. After auction, successful Bidders shall have to deposit 25% amount of the final bid on the spot before leaving the YASHADA premises. It is therefore necessary that all the Bidders Shall be present at the time of opening of the price bid at YASHADA on 26/03/2024 at 11.00 hours.

**07.** All applicable Tax / Insurance except road taxes Shall be Payable by the bidder over and above the bid price.

**08.** Possession Sale letter will be issued only in the name of Bidders under which offer is made. Vehicles should be removed from YASHADA premises within four days from the handling over of sale letter.
